A receipt will be provided for all payments made at the YWCA. I acknowledge that I cannot give payment to Child Enrichment Site staff, and that all payments are to be made with YWCA administrative personnel. I acknowledge a \$25 fee will be charged for all returned checks or refused EFT payments. The YWCA reserves the right to require cash, credit card, or money order payments for repeated returned checks or refused EFT payments. Repeated NSF payments may result in child's dismissal from our programs.

I acknowledge that I must, as soon as possible, notify the YWCA front desk or the Child Enrichment Director at (618) 465-7774 if my child is going to be absent from the program.

I acknowledge that I must notify the Child Enrichment Director in writing two weeks in advance if I elect to remove my child from the YWCA Child Enrichment Program.
